PUBLIC TRANSPORTATION (BRT): IN BRAZIL, RIO DE JANEIRO'S TRANCARIOCA  
CORRIDOR OPENED AND WAS AWARDED A BRT STANDARD GOLD RATING. THE BRT IS  
EXPECTED TO SERVE 320,000 PASSENGERS DAILY AND REMOVE NEARLY 500 BUSES  
FROM THE STREETS. IT FEATURES PLATFORM-LEVEL BOARDING, DEDICATED LANES,  
ACCESSIBLE STATIONS, AND CLEAR PASSENGER INFORMATION, WITH BUS  
TIMETABLES AND ROUTES. AIR-CONDITIONED, BI-ARTICULATED BUSES CARRY 180  
PASSENGERS, MOVING MORE PEOPLE THAN TRADITIONAL BUS SERVICE AT A FASTER  
PACE. RIO WILL SEE TWO ADDITIONAL CORRIDORS, TRANSOL MPICA AND  
TRANSBRASIL, OPEN BY 2016. IN ADDITION TO THE BRT DEVELOPMENTS IN RIO,
